STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your complainant is a licensed peace officer employed by the Rochester Police Department. In that capacity your Complainant has reviewed the police reports relating to Arkady Pavlovich Pichurin, the above-named defendant, and the allegations contained therein. Based upon that information, your complainant believes the following to be true and correct.

December 4, 2020, two cyber-tips were referred to the Rochester Police Department. Inv. Novak began to look into these tips and saw that three more tips were forwarded to the Rochester Police Department on January 6, 2021. The tips provided a username, date of birth, email, and IP address. According to the tip, six files were uploaded and those files were recognized as being previously submitted to the National Center for Missing & Exploited Children. The IP address was identified as belonging to ARKADY PICHURIN (DOB 9/8/94). The IP address registered to a residence in NW Rochester, MN, Olmsted County. Inv. Edge confirmed that Pichurin still resided at the NW residence and that Pichurin had lived at the residence since September 2019.

On January 15, 2021, a search warrant was executed at Pichurin's residence. The MN BCA Digital Media Evidence laboratory assisted in the investigation and previewed devices. Multiple devices were seized from the residence including a Motorola G-6 cell phone, Samsung Note 8, and Asus Vivo book. Inv. Edge reviewed extraction reports and noted that there were hundreds of images that appeared to be child pornography. In the Asus Vivo book, there were multiple Snapchat usernames found. Inv. Edge noted that there was a file with the name Victim (juvenile female identified in police reports under the age of 10). Further investigation revealed that Victim resides in New York. In the file associated with Victim, there were over 90 videos and 169 images of Victim.

The videos begin in October 2020 and go until January 2021, Victim would have been eight in October 2020. The videos range from being conversations to being sexually explicit. Victim appears in many of the videos, there are also many videos of other juvenile females engaging in sexually explicit acts that are sent by Pichurin to Victim. Victim appears in a video and there is text that says "kiss me baby." Another video is of Victim dancing. A fourth video is of a female performing oral sex, the video then transitions into Victim in a sports bra and pants. The next video is of a female going to the bathroom. There is then a text exchange between Pichurin and Victim. Pichurin asks Victim how old she is, and she says 12. Pichurin then says Victim looks younger and he would like to see her whole body naked again. In another video from November 2020, there is a white female exposing her anus and vagina in a lewd manner. The video stops and transitions into a chat. Pichurin says to Victim "you are so sexy. What do you want from me?" He then says, "can you spread your butt so I can see your butt hole." It appears that two videos were sent by Victim. Victim then asks Pichurin if he can be her boyfriend. A sixth video is of Victim nude. The video also shows Pichurin. The seventh video is of Victim showing her vagina and anus in a lewd manner. A seventh video is of Victim wearing pink underwear and posing for the camera. The eighth video shows Victim exposing her buttocks by pulling the cheeks apart and exposing her anus and vaginal lips.

Many Snapchat conversations were saved. One conversation included Pichurin telling Victim that she looks younger and that he wants to see her whole naked body again. In that same conversation he asks Victim to record herself going to the bathroom and to wear her sexiest underwear. There are videos of Pichurin calling Victim via video chat, one shows a timestamp of January 6, 2021. A video from November 8, 2020, shows Victim exposing her buttocks and rubbing her anus, she also exposes her vagina to Pichurin during

a video call. In a video from December, Victim is dancing in a sports bra and shorts. Pichurin tells Victim multiple times to take her shorts off, she never does. A video of a chat message in which Pichurin tells Victim to "do that same video but move your panties to the side." "Video it for me baby" is shown. Victim then sends a video. Pichurin responds with "that was so sexy." In that same video Victim is wearing a floral top. The next video is of Victim pulling up her dress and spanking herself. In another video Victim is exposing her breasts. Three videos are located of Victim exposing and manipulating her vagina. Another video appears to be of a call between Pichurin and Victim. Victim is exposing her vagina and penetrating herself.

There were numerous videos that were sent to Victim from Pichurin of juvenile females going to the bathroom, exposing their intimate parts, and engaging in sexual conduct. In some of the messages, Pichurin asks Victim if she likes the videos he sent her. Chats between Pichurin and Victim include Pichurin asking Victim to send him nude photos of her. It appears that she does. Pichurin also has video calls with Victim in which he is masturbating and asking to see Victim's body.

PLEASE TAKE NOTICE: YOU MUST APPEAR FOR EVERY COURT HEARING REGARDING THIS CASE. FAILURE TO APPEAR FOR COURT IS A CRIMINAL OFFENSE AND MAY RESULT IN ADDITIONAL CRIMINAL CHARGES BEING IMPOSED AND PUNISHED AS PROVIDED IN MINNESOTA STATUTES SECTION 609.49.
