









# Selected Long-term Vision

### Implementation Strategy Approach



The timeframe for the selected long-term vision is 2040+



Implementation of the selected long-term vision is expected to be incremental and occur in stages over time



Estimated implementation stages are short-term (5+ years), mid-term (10+ years) and long-term (20+ years)







An official map is prepared by a licensed land surveyor and adopted by local jurisdictions with zoning authority such as counties, cities, or townships.



After adoption, the Official Map is filed with the County Recorder who notes the existence of the official map on all affected property titles.





I attended many meetings since the inception of the conversations on this process. I understand the numerous attempts and failures to make progress on securing access to the highway.  I have hundreds of emails and documents to and from local, county and state officials. Hundreds of communications with local business associates and a long standing knowledge and history with the access situation.  I would be happy to have an in-depth conversation with officials on details of how we arrived to were we are today.  I will briefly summarize why there should be "no question" on the location of future access to the highway. Byron has invested tax payer money and planned traffic patterns, business developments and diligently pursued conversations with State and County officials on an East side 10th Avenue access and has presented that location (with another west side location) as the City's preference. To clarify my interest in keeping engaged in the entire process over the years - I built the grocery store that has been since sold to Kwik Trip. During the Open House 3 a question was posed as to why a combination of interchanges at County 5 and 10th Avenue was not presented as an option. Could someone elaborate on specific disqualifying criteria as to why this combination of accesses is not a viable option? Some general commentary about access spacing was stated during the meeting but nothing specific. There is a multitude of examples of such access spacing in nearby communities (approximately 1 mile). Several I35 interchanges in Owatonna are 1 mile apart. Dodge Center and Owatonna, as well as Claremont's future interchanges with highway 14, are all approximately 1 mile apart. This combination of interchanges would provide continued access to the current 2 most heavily utilized highway 14 intersections in Byron and allows for furtherance of the 30 year comprehensive plan provided by the City of Byron. Future economic growth was listed as a primary consideration in the development of the corridor plan. During the open house it was stated by the presenters that simply having a decision was good for economic growth potential. Given the proposed layout and plan for implementation, it could be argued that a substantial portion of existing and near-future economic development is stifled for the trade-off of potential growth 10-20+ years into the future. The imminent restriction and subsequent closure of 10th Avenue access will have immediate detriment to business in that area (not 10-20 years down the line as suggested). Businesses that recently invested in the area using the 30 year comprehensive plan of the city as a guide have drastically lessened long-term potential with the proposed plan. This access restriction/closure will stifle short and mid-term economic development as new construction or reinv	Open House 3
