





Design Solutions

- Reconstruct Roadway in Concrete 50 year design life
 - Improve sight lines to meet standards
 - Reconstruct with Standard Typical Section Meets ulletexpectations and is consistent with other County Roads in the Area
- Regrade ditches to standard size to improve flow and deal with storm events
 - Raise low areas of roadway and improve culvert • crossings to address 50 year storm event from North and West.



County 25 - Typical Sections







