OLMSTED COUNTY SHERIFF'S OFFICE CIVIL PROCESS FEES

Please be aware that all Olmsted County Sheriff's Office fees for Civil Process requests require prepayment and are non-refundable. For any services not specified herein, the Sheriff shall be entitled to the same fees as for similar duties.

Service of legal documents related to a court action. Service is not guaranteed, a diligent search and a minimum of three (3) attempts for service will be made prior to returning any documents as not found.	\$100.00	per service (per individual / case)
Administrative office work required or requested on behalf of clients	\$100.00	1-hour minimum
Conducting Sheriff's Sales (ie. Mortgage Foreclosure Sales, Execution Sales, Lien sales)	\$100.00	per sale
Deputy standby for enforcement of a Writ of Recovery of Premises & Order to Vacate or any other standby for retrieval or exchange of personal property (2-hour maximum)	\$100.00	per hour (2-hour maximum)
Posting Notices of Sale (3 Public Places)	\$150.00	per Notice of Sale
Preparation of a Notice of Sale	\$200.00	per Notice of Sale
Preparation of Certificate of Sale	\$200.00	per Certificate of Sale
Preparation of Report of Sale	\$200.00	per Report of Sale
Publication of Notice of Sale	\$1,000.00	<u>minimum deposit</u> - additional publication fees may apply
Secured Party Payoff Request	\$100.00	per lien request
Mortgage Foreclosure Redemption (MSA 580.25)	\$250.00	per Redemption
Jr. Creditor Notice of Intent to Redeem (MSA 580.24)	\$100.00	per Notice of Intent

Seizure and recovery of personal property (ie. Replevin Order, Order for Seizure, Writ of Attachment) NOTE: Sheriff's Office recovery and storage fees to be paid <u>prior</u> to release of personal property seized.	\$200.00	<u>minimum</u> deposit - additional Sheriff's fees for recovery and storage to be applied (ie. tow, lock-smith, storage)
Writ of Execution - Service of a bank levy, wage levy or personal demand	\$100.00	per service
Writ of Execution - Till Tap (2 - Deputy Requirement)	\$200.00	1-hour
Writ of Execution - Commission for collections made on judgments	5%	5% of judgment funds collected
Writ of Execution - Seizure and sale of personal or real property (NOTE: Fees dependant on property to be seized. Publication fee is <u>not</u> included in minimum deposit - if publication necessary, additional deposit required)	\$1,250.00	<u>minimum</u> deposit - additional Sheriff's fees may apply
Storage for seized property (seizable property - Non-Bulky property <u>only</u>)	\$20.00	per day
